

It's all in the Numbers

Numerology is the study of numbers and their meanings and when applied to life, Numerologists believe that understanding numerology can enhance the quality of the time you spend on Earth - give you insights into your future, a little like a weather forecast. It can reveal some of the challenges that lie ahead of you as well as things that will work in your favour, so that you can plan. Esther Teh is a Numerologist and here gives EL readers an introduction to how it works.

Popular numerology methods include Pythagorean, Verdic and Chaldean. No one method is better than the other - very simply, to understand your numbers, pick one that you can 'vibrate' to. Calculating your Personal Year Number gives you an outline, and allows you to plan and manage your life, supporting you in achieving your goals.

To calculate your Personal Year Number, add the date and month of your birth to your Universal Year Number. For example, if you were born on February 8, 1946 you add up the date and month i.e. $8 + 2$, which gives you 10. Further reduce this to a single digit, i.e. "1".

The Universal Year Number is calculated by adding the digits of the current year, and reducing it to a single digit i.e. $2005 = 2 + 5 = 7$. Add the Universal Year Number to the "1" = $7 + 1 = 8$. So, if you were born on the February 8, you would be in Personal Year 8, in Year 2005.

Interpretations

Personal Year 1

Time of new beginnings - new job, new career, new business or project. Do something original; get out and meet new people or expect to meet new others who will bring new ideas. Expect to be active and busy. A good year for dating and meeting new people.

Personal Year 2

Be diplomatic; be agreeable. Participate in group activities. If you are planning to marry this year, be open to the possibility that you are marrying because you don't want to be alone.

Personal Year 3

A social year. Marriage this year is good, with happy times but of course still the usual problems. Manage your expectations. Watch what you spend, especially on clothing, and remember to work.

Personal Year 4

You workaholic! Remember to have some fun, balance is the key. If single, you may marry someone who is divorced or widowed with children and may find yourself becoming the main breadwinner.

Personal Year 5
